- 1. Call to Order
 - a. G. Slay called the meeting to order at 10:01 AM.
- **2. Previous Meeting Minutes**: K. Kenter motioned to approve the previous meeting minutes. S. Satke seconded the motion. All in favor—motion passes.
- 3. RFP for Snow Removal Services: G Slay shared that the Swinter Group was at capacity and was not able to submit an RFP. C Holt shared that PCD had reached out to 15 companies; however, all responded that they did not service such a large footprint, were at capacity, or did not provide services in our area. D Bellon shared that it would be hard to find a company that serviced such a large area. G Slay shared that business/property owners would continue to have to complete this until services could be acquired.
- 4. RFP for Landscaping Approval: C. Holt gave an overview of the RFP, highlighting the deadline for submission and scope of services. T Telnikova shared that she had issues with late night patrons of the Grove CID destroying her flowers and asked if anyone else had the issue. G Slay shared that he had not had that issue. D Bellon motioned to approve the RFP with the addition of Fall flowers being added to the scope of services; A. Saputo seconded. All in favor motion passed. D Bellon recommended contacting businesses closest to planters to provide watering during the summer.
- **5. Update Trash Cans Approval**: C Holt gave an overview of options to replace broken and missing trash cans. S Satke shared that Anova had recently moved near the district and could provide trash cans at a lowered rate. T Telnikova favored the

netted trashcans as they could reduce graffiti. D Bellon recommended black cans as they would show less deterioration. T Telnikova motioned to reach out to Anova for trash can replacements; A Saputo seconded. All in favor – motion passed.

- **6. Manchester Bollard Study**: G Slay highlighted the benefits of pursuing bollards, noting the car accident that occurred at the intersection of Manchester and Tower Grove in April. C Holt shared that he has been working with MoDOT to figure out next steps.
- **7. Holiday Décor**: S Satke shared that she is currently waiting on final revisions for the holiday banners but should here back soon. S Satke recommended that wreaths be ordered soon.

8. Other Business:

- **a.** G Slay welcomed A. Saputo as the newest member of the board.
- **b.** D Bellon motioned to donate \$300 to Bright Side STL for volunteering to clean the planters. G Slay seconded. All in favor motion passed.
- **c.** S Satke recognized C Holt for GroveFest, noting the success of the event and the level of professionalism by the PCD team. L Coleman shared that it was the best GroveFest yet.
- **d.** J Boldt asked when the alleyway paving was approved and thanked the Grove CID for taking on the project. K Kenter shared that the project was approved by the Executive Committee in 2021.
- **9. Adjournment:** G. Slay adjourned the meeting at 10:50 AM.
