1. Call to Order

- a. G. Slay called the meeting to order at 11:05 am.
- **2. Previous Meeting Minutes**: S. Satke motioned to approve the previous meeting minutes. J. Boldt seconded the motion. All in favor—motion passes.
- **3. Landscaping**: G. Slay stated that Shelton Landscaping will start around May 10 to mulch tree wells and fill planters. There is a concern about who will water the plants. T. Saputo suggested that he will reach out to businesses see if they will water the planters in front of their businesses. A. Abdullah thinks that watering should be a part of the contract. Although if it's not, there might be an additional cost to water the plants. The committee agreed the plants should be watered.
