Grove CID Executive Committee Meeting Minutes July 7th, 2022 at 2:00pm ZOOM

Committee members present: Kelly Kenter, Don Bellon, Kelly Spencer, Matt Bauer, Chad Fox

Committee members not in attendance: Chip Schloss

Others in attendance: Codi Holt (Park Central)

1. Call to Order: K. Kenter called the meeting called to order at 2:02 PM.

2. Approval of Previous Minutes: K. Kenter made a motion to approve the minutes. D. Bellon seconded the motion. All in favor, motion passes.

3. Discussion of TCF Interview:

a. The committee reviewed the information Rob Betts shared during the interview. K. Kenter shared that throughout his 20 years of knowing R. Betts that he is a thorough individual that would benefits the Grove security initiatives. K. Spencer share that they are the largest and most professional secondary service provider in the city. D. Bellon asked C. Fox to share how responsive TCF has been at his establishment and asked who would be watching the patrols. C. Fox shared that TCF has been responsive in the past. K. Spencer committed to being involved in overseeing that TCF is present in the district during their scheduled hours. C Fox mentioned the benefits of having QR codes in the businesses and providing business owners with a direct line to TCF for emergencies. C. Fox motioned to recommend TCF patrol services to the board; K. Spencer seconded. All in favor – motion passes.

4. Flock Camera Proposal:

- a. C. Holt explained that the NSI sent the district a proposal suggesting four (4) license plate identifying cameras to the Grove camera system. C. Holt explained that the costs for leasing the cameras would be \$2,500 per camera each year. M. Bauer expressed that the ongoing costs were high and suggested seeing if they could be reduced. K. Kenter spoke to the benefits of the camera system in increasing security in the Grove and reducing management of the cameras. C. Fox motioned to move forward with the proposal after PCD spoke with Flock to clarify pricing; M. Bauer seconded the motion. All in favor motion passes.
- **5. Other:** K. Kenter suggested to keep the Join Executive and Safety and Security Committee intact until the new contract with TCF was finalized and K. Spencer is prepared to take on direct communications with TCF.
- **6. Adjournment:** K. Kenter adjourned the meeting at 2:37 PM.



EVENTS IN THE GROVE

The GROVE continues to be a hub of activity and events in the city, attracting tens of thousands of locals and tourists to the district. The following outlines a list of events hosted this past fiscal year:

GroveFest

GroveFest is the annual festival of all things Grove. Vendors from around the City sell food and goods on the street, businesses bring tents and games out, children play in the kids area with bubbles and bounce houses, and there is an unlimited amount of live entertainment from jugglers and dancers to fashion shows.

Moonlight Ramble

The Moonlight Ramble hosted its 57th moonlit bike ride of varying length (7-18 miles), which always takes place on the Saturday closest to the Full Moon in August. The event draws riders of all ages and abilities to safely enjoy riding the streets of STL traffic free while enjoying the full moon. This past year, the ride started and finished in the Grove, and thousands came early and stayed late patronizing the bars and restaurants in the Grove.

Oktoberfest

Urban Chestnut Brewing Company (UCBC) held its 11th annual Munich-style celebration--featuring live music, German beer, food, and activities--in the Grove this past year. This two-day festival featured a full lineup of rock, blues, and polka music on two stages as well as yard games for all to enjoy.





Manchester Bike Bash

This international event celebrating bikes and bodies meets up in the Grove every year and includes pre-ride festivities including body painting and a costume contest. Event goers can paint their bodies,

decorate their bikes, and join th ethousands of cyclist for a ride around the city. An after party then occurs in the Grove and features live music, local food

and drinks, and so much more.

Flyover Comedy Festival

Flyover Comedy Festival remains unique as a festival, highlighting multiple venues on both the east and west ends of The Grove. The event took place at multiple venues on Manchester, which allowed all of The Grove's remarkable restaurants, bars, and venues to be showcased.

Green Curbside Hop Donation

Celebrating Green Dining options in the Grove, this scavenger hunt traversed through restaurants all down Manchester and included samples for all involved.

Participants who completed the scavenger hunt received bonus prizes at earthday365 group's booth! Winning prizes included a bike, a Green Dining Alliance Gift Bag and more.



CID Expansion

The Grove CID is currently expanding to capture more sales tax revenue and increase overall dollars for the district.

Security Patrol & Management

During this fiscal year, the district transitioned and partnered with Washington University Medical Center Redevelopment Corporation to provide security patrols for the district.

Social Media

The CID is still working with Engaged Taste to manage and provide a more consistent online presence.

Additionally, the district is working with Explore STL to expand outreach.



Grove Signs

Zimmerman will continue to provide support with the Grove signs. Their annual inspections help ensure the structural integrity of the signs.

Assessment

The CID Assessment renewal petition is currently being reviewed by the attorney. In this new assessment, the board voted to lower tax by 25% and extend the assessment term to 5 years.

Landscaping, Maintenance & Admin






Public Improvements 25.1%
