  - f. R. Hayden voiced concern about crime and communication. There are many car break-ins at her business, and she is not seeing action on these break-ins.
4. **NSI Camera Proposal:** A. Graham presented the proposal form the NSI on cameras.
  - a. The Committee discussed the current camera strategy and decided not to pursue additional cameras at this time.
5. **Security Management RFP:** A. Graham presented the Security Management RFP as written.
  - a. A. French asked for specific metrics to be added to the RFP. He also would like to see the patrols building relationships with the businesses.
  - b. A. Johnson gave background on the NSI process for new members.
